# TO OUR MEMBERS

The Managing Committee of the ISTD Delhi Chapter is pleased to present the Annual Report together with the Audited Statement of Accounts of the Chapter for the period ended 31st March 2023.

## 1. Chapter Performance

When your new Managing Committee took over, albeit a bit late in November 2022, they were acutely aware of the herculean task of filling the large boots left behind by previous committees. And coming as it did after a hiatus caused by the worldwide pandemic, we had to relearn how to interact face to face, in person. We tried our best. And the activities and initiatives of the last 8 months are testimony to our honest endeavours. But then, you, the members, are the best judge as to whether we succeeded in our modest attempt and whether we are on the right path. We have thoroughly revamped our website which now is a repository of all activities, past and upcoming, along with MOMs, pictures, and videos.

Our **Mission Reboot Delhi Chapter 2.0** rested on **4 planks** – *to bind all our members as one; to give opportunities to as many members to showcase their L&D talent; outreach to the industry, corporates and academia; and contribute to the NHQ initiatives.* In all, we could squeeze into the short 8 months period **12 initiatives**, gave opportunities to **96 members**, reached out to **13 industry leaders** and garnered **75300 social media impressions**.
